ANNOUNCEMENT OF OFFER PRICE AND ALLOTMENT RESULTS

SUMMARY

Offer Price and Net Proceeds

- The Offer Price has been determined at HK\$1.38 per Offer Share (exclusive of brokerage of 1%, SFC transaction levy of 0.0027% and the Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$1.38 per Offer Share and 120,000,000 new Shares offered by the Company (before any exercise of the Over-allotment Option), the net proceeds from the Share Offer to be received by the Company after deducting underwriting commission and estimated expenses in connection with the Share Offer, are estimated to be approximately HK\$135.6 million. The Company intends to apply such net proceeds in the manner set out in the paragraph “Offer Price and Net Proceeds” below in this announcement.

Applications under the Public Offer and indications of interest received

- The Offer Shares initially offered under the Public Offer has been very significantly over-subscribed. A total of 12,833 valid applications under the Public Offer have been received for a total of 541,476,000 Public Offer Shares, representing approximately 45.12 times of the total number of 12,000,000 Public Offer Shares initially available under the Public Offer.
- Due to the over-subscription in the Public Offer, the reallocation procedures as described in the section headed “Structure and Conditions of the Share Offer — Basis of Allocation of the Offer Shares” in the Prospectus have been applied. As the number of Offer Shares validly applied for under the Public Offer is 15 times or more but less than 50 times of the number of Offer Shares initially available under the Public Offer, a total of 24,000,000 Offer Shares initially available under the Placing have been reallocated to the Public Offer, so that the total number of the Public Offer Shares has been increased to 36,000,000 Offer Shares, representing 30% of the Offer Shares initially available under the Share Offer (before any exercise of the Over-allotment Option).

Placing

- The Offer Shares initially offered under the Placing has been slightly over-subscribed. Following the reallocation described above, the final number of Offer Shares under the Placing is 84,000,000 Shares, representing approximately 70% of the Offer Shares initially available under the Share Offer (before any exercise of the Over-allotment Option).

- A total of 70 placees who have been allotted 5 board lots of Shares or less represented approximately 40.2% of total number of placees under the Placing. These placees have been allotted 1.02% of the Shares under the Placing (as adjusted after reallocation). In addition, a total of 9 placees who have been allotted 1 board lot of shares represented approximately 5.2% of total number of placees under the Placing. These placees have been allotted 0.04% of the Shares under the Placing (as adjusted after reallocation).
- The Directors confirm that no Offer Shares under the Placing has been allocated to Directors or chief executive officers or existing Shareholders of the Company and/or any of its subsidiaries, or their respective close associates, or core connected person (as defined in the Listing Rules) of the Company, whether in their own names or through nominees. The Placing is in compliance with the placing guidelines for equity securities as set out in Appendix 6 to the Listing Rules. None of the Sponsor, the Joint Bookrunners, the Joint Lead Managers, the Underwriters, and their respective affiliate companies, and connected clients (as defined in Appendix 6 to the Listing Rules) has taken up any Offer Shares for its own benefits under the Share Offer. The Directors confirm that no placee will, individually, be placed more than 10% of the enlarged issued share capital of the Company immediately after the Share Offer. The Directors confirm that none of the placees under the Placing will become a substantial shareholder (as defined under the Listing Rules) of the Company immediately after the Placing and the number of Shares to be held by the public will satisfy the minimum percentage prescribed by Rule 8.08(1) of the Listing Rules. The Directors further confirm that there will be at least 300 Shareholders at the time of the Listing in compliance with Rule 8.08(2) of the Listing Rules and that the three largest public shareholders of the Company do not hold more than 50% of the Shares held in public hands at the time of the Listing in compliance with Rules 8.08(3) and 8.24 of the Listing Rules.

Cornerstone Investor

Based on the Offer Price of HK\$1.38 per Offer Share, the net proceeds from the Share Offer to be received by the Company, before any exercise of the Over-allotment Option, after deducting underwriting commissions and estimated expenses in connection with the Share Offer, is estimated to be approximately HK\$135.6 million.

The Group intends to apply such net proceeds from the Share Offer as follows:

- approximately HK\$88.1 million or approximately 65.0% of the net proceeds to purchase four presses (three offset presses and one digital press) to maintain and enhance our production capacity. We plan to spend such expenditures by stages within six years after the Listing;
- approximately HK\$33.9 million or approximately 25.0% of the net proceeds to relocate our Shenzhen Factory. It is expected that the capital expenditure for refurbishing the new plant will be at approximately HK\$28.2 million and the logistic expenses will be at approximately HK\$5.7 million. We plan to spend such expenditure by stages for the year ending 30 June 2019 after the Listing;
- approximately HK\$4.5 million or approximately 3.3% of the net proceeds to upgrade our enterprise resources planning (ERP) system. We plan to spend such expenditures by stages within two years after the Listing; and
