The Board announces that all the ordinary resolutions as set out in the notice of annual general meeting of the Company dated 28 October 2021 were duly passed at the annual general meeting of the Company held on 7 December 2021 by way of poll.

Reference is made to the circular of Sun Hing Printing Holdings Limited (the “**Company**”) dated 28 October 2021 (the “**Circular**”) in relation to the proposals relating to general mandates to repurchase shares and to issue new shares, re-election of directors and notice of annual general meeting. Unless otherwise stated, terms defined herein shall have the same meanings as those defined in the Circular.

As at the date of the AGM, the total number of Shares in issue was 480,000,000 which was also the total number of Shares entitling the Shareholders to attend and vote for or against Resolutions numbered 1 to 10 at the AGM. The Shareholders of the Company and authorised proxies holding an aggregate of 381,696,000 Shares carrying voting rights voted at the AGM. There were no Shares entitled the holders to attend and abstain from voting in favour at the AGM as set out in Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and no Shares of the holders of the Company were required to abstain from voting at the AGM under the Listing Rules. There was no Shareholder who entitled to attend the AGM but was only entitled to vote against any of the Resolutions.

The Company's branch share registrar, Tricor Investor Services Limited, acts as the scrutineer for the purposes of vote-taking at the AGM.

As more than 50% of the votes were casted in favour of each of the above Resolutions numbers 1 to 10, the above Resolutions were duly passed as ordinary resolutions of the Company.
