• registering new issues or transfers into or out of the names of securities' holders including, where applicable, HKSCC Nominees;

maintaining or updating the register of

securities' holders of the Company;

• verifying securities holders' identities;

• establishing benefit entitlements of securities' holders of the Company, such as dividends, rights issues, bonus issues, etc.;

distributing communications from the Company

and its subsidiaries;

compiling statistical information and securities' holder profiles;

disclosing relevant information to facilitate

claims on entitlements; and
any other incidental or associated purposes

3. Transfer of personal data
